

Trial End User Licence Agreement

This Trial End User Licence Agreement ("Agreement") is a legal agreement between the entity you represent ("Licensee") and **Technical Simulation Consultants Ltd** ("Licensor" or "TSC") for the evaluation version of the software accompanying this Agreement ("Software"). By installing, copying, or using the Software, you agree to be bound by the terms of this Agreement.

1. Grant of evaluation licence

TSC grants the Licensee a non-exclusive, non-transferable, time-limited evaluation licence to install and use the Software solely for internal testing, evaluation, and trial purposes. Commercial production use of the Software during or after the trial period is strictly prohibited.

2. Trial period and data extraction restrictions

- **Trial duration:** This licence automatically expires at the end of the designated evaluation period specified by TSC or upon thirty (30) days from installation, whichever is earlier.
- **Data extraction prohibition:** The Licensee is strictly prohibited from extracting, exporting, scraping, or downloading any data, reports, configurations, or outputs generated by the Software for use outside of the evaluation environment or beyond the trial period.
- **Data deletion:** Upon expiration of the trial, any data remaining within the Software, or any outputs derived from it, must be permanently deleted and cannot be migrated to other operational systems.

3. Updates and maintenance disclaimer

This Agreement governs the specific evaluation version of the Software provided. TSC is under no obligation to provide updates, upgrades, patches, bug fixes, or technical support.

4. Deployment limits

The usage of the Software is restricted by the following boundaries:

- **Deployment metrics:** The Licensee may only install and execute the Software up to the maximum number of users, seats, or designated devices specified in the applicable purchase order.
- **No concurrent sharing:** Licences assigned to specific users or devices cannot be shared or used concurrently by multiple parties unless explicitly authorized in writing.

5. Evaluation restrictions

The Licensee agrees to adhere to the following operational boundaries:

- **No modification:** Do not alter, adapt, modify, or create derivative works of the Software.
- **No engineering:** Do not decompile, disassemble, decrypt, or reverse engineer the source code.
- **No redistribution:** Do not rent, lease, lend, sell, distribute, or sublicense the Software to external third parties.

6. Intellectual property

The Software is licenced for evaluation, not sold. TSC retains all right, title, and interest in and to the Software, including all copyrights, patents, trade secrets, trademarks, and corporate intellectual property rights.

7. Termination

This Agreement automatically terminates at the end of the trial period, or earlier if the Licensee fails to comply with any material term. Upon termination, the Licensee must immediately cease all use of the Software, cease using any data generated during the trial, and permanently delete all copies of the Software and related trial outputs from all systems and hardware.

8. Limitation of liability

The Software is provided "as is" and "with all faults" for evaluation purposes only. To the maximum extent permitted by law, TSC shall not be liable for any commercial losses, lost profits, data corruption, business interruption, or consequential damages arising out of the use or inability to use the Software.

9. Governing law

This Agreement shall be governed by and construed in accordance with the laws of the United Kingdom, without regard to its conflict of law principles.
